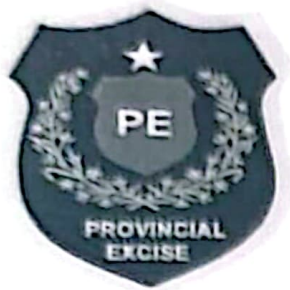

- i) They shall, for all intents and purposes, be Civil Servants, except for the purpose of pension and gratuity.
- ii) They shall be governed by the Khyber Pakhtunkhwa Civil Servants Act, 1973, (Amendment), 2022, except for purpose of pension and gratuity, and in lieu of pension and gratuity, they shall be entitled to receive such amount contributed by them towards Contributory Provident fund (C.P Fund), along with the contributions, made by government to their accounts in the said fund, in the prescribed manner.
- iii) They shall be governed by Khyber Pakhtunkhwa Civil Servants Act, 1973, (Amendment), 2022, and all the laws applicable to the Civil Servants and Rules made there-under.
- iv) They shall, initially, be on probation for a period of one year extendable for a further period of one year.
- v) Their services shall be liable to termination at any time without assigning any reason thereof before the expiry of probation period, if his work/performance during this period is not found satisfactory. In such an event, he / she shall be given a month's notice of

termination from service or one month's pay in lieu thereof will be paid. In case he / she wishes to resign at any time, a month's notice shall be necessary or in lieu thereof a month's pay shall be forfeited.

- vi) They shall be liable for posting / transfer anywhere in Khyber Pakhtunkhwa.
- vii) They shall not be entitled to any T.A/D.A on their first appointment.
- viii) This offer is subject to the verification of their educational credentials, character & antecedent verification as well as certificate of physical fitness (Medical Certificate) from the concerned Authority.
- ix) They shall undergo all types of physical trainings as prescribed by the department.
- x) The Inter-se seniority of the candidates shall be in accordance with the order of merit.

If the above, terms and conditions are acceptable, they shall report for duties within (30) days from the issuance of this order to this Directorate General Excise, Taxation & Narcotics Control Khyber Pakhtunkhwa.
